

**PHIL 201A: Core Course in History of Philosophy
Spring 2011 Spinoza's *Ethics***

The goals of this seminar are to undertake a careful study of Spinoza's *Ethics* (1677); to acquire an understanding of the scope of Spinoza's philosophical project and the details of the doctrines he defends; and to address some of the outstanding interpretative issues raised in the recent secondary literature. This is a core course in the history of philosophy, which means that it makes no assumption that participants will have read Spinoza before; as a graduate seminar in philosophy, however, it assumes that you will work to get up to speed quickly on the material and engage the texts and issues in a serious manner.

Required Text

A Spinoza Reader, ed. and trans. Edwin Curley (Princeton, 1994). All other readings will be made available in electronic form.

Course Requirements

The seminar will involve alternating meetings devoted to explication of the basic doctrines (odd weeks) and deeper analysis of particular topics (even weeks). All participants are expected to do all the assigned reading each week. On odd weeks, I will take the lead in presenting Spinoza's views; on even weeks, participants will take the lead in exploring topics through recent articles (4-6/week) from the secondary literature. In the lists of articles below, \$ indicates a good background source, # indicates a target article for discussion.

Everyone registered for credit will be required to submit a 15-20 term paper by Tuesday of exam week (June 7). I will meet with all registered students to discuss your paper topics during 9th week. Final grades will be determined as follows: Term paper = 75%; Participation = 25%.
