

**Fall 2013, Phil 87: Individual Liberty and its Limits**  
**Professor Jerry Doppelt**

*The topic of the seminar concerns the value of individual liberty and the question of when society is justified in using the law to restrict individual liberty. We will be reading John Stuart Mill's classic *On Liberty* and looking at controversies over the extent of liberty that arise in connection with the use of recreational drugs, the problem of hate speech, the issue of restricting pornography, and the use of law to prevent actions that the community considers immoral – for example, flag burning, public nudity, and similar actions.*
